#### CONSTITUTIONAL AMENDMENT FULL TEXT

## **Article and Section Being Created or Amended:**

Article I, Section III

### **Full Text of the Proposed Amendment:**

SECTION 3. Religious Freedom.-- There shall be no law respecting the establishment of religion or prohibiting or penalizing the free exercise thereof. Religious freedom shall not justify practices inconsistent with public morals, peace or safety. No revenue of the state or any political subdivision or agency thereof shall ever be taken from the public treasury directly or indirectly in aid of any church, sect, or religious denomination or in aid of any sectarian institution. The First Amendment protects the right to free speech respecting religion from the Laws and Constitution. Prayer in schools supports freedom of speech. Prayer is not an expression of religion or denomination. Prayer represents unity, an awakening, a release of oneself, and spiritual consciousness. Prayer is a devotion necessary to advance our children. Church and State's practices include family values and morals, culture, and diversity for all people.
