## CONSTITUTIONAL AMENDMENT FULL TEXT

### Article and Section Being Created or Amended:

Article IX, Section 1 Public Education

### Full Text of the Proposed Amendment:

Section 1 Public Education

In order to impress upon the minds of our growing-up generation that the world in which they live is not a jungle, where brute force, cunning and unbridled passion rule supreme, but that it has a Master Who is not an abstraction, but a personal God; that this Supreme Being takes a "personal interest" in the affairs of each and every individual, and to Him everyone is accountable for one's daily conduct, the people of the State of Florida establish the following non-denominational prayer for public school students grades K-12:

"Almighty God, we acknowledge our dependence upon You, and we beg Your blessings upon us, our families and our country."

The procedure of the recitation of this prayer being that the students read it together with the teacher at the beginning of each school day.

Anyone who is a conscientious objector to this prayer will be excused from saying it.
